Terms & conditions: -

1. The rates should be quoted F.O.R. IISS, NabiBagh, Berasia Road, Bhopal.
2. Quantity of discount, if any, should be indicated clearly.
3. Rates of Sales Tax, VAT, Service Tax and other taxes leviable should be indicated in clear terms separately. Sales Tax, VAT, TIN etc. Registration Number both under State and Central Tax Act/Rules should be separately indicated.
4. Unless otherwise mentioned in the quotation, it will be presumed that the quoted rates are inclusive of all taxes/levies and free delivery at our Institute.
5. The rates quoted should be valid for 90 days from the date of opening of quotation.
