01	Length of tube: 1.5 m with an internal diameter of approximately 2cm for soil sampling. Tube should be constructed from high quality abrasion resistant, high tension strength steel. Sampling tube should be marked at 15 cm interval for depth identification  Accessory items: 1. Drop Hammer (01 No): It should be compatible with the tube auger and work properly for driving the sampling tube into the soil. 2. Replaceable compatible point/cutting edge (04): Cutting point and head machined from stress proof steel, threaded for easy replacement. Cutting edge should be made of steel and should not bend when strikes hard object. 3. Puller Jack (01 no): Complete set with accessory like handle, gripper jaw and base to aid in removing the auger from the soil.	01		

**Relevant terms & conditions are as below: -**

01. The rates should be quoted F.O.R. IISS, Nabi Bagh, Bhopal basis along with indicating separately brand name its price, packing forwarding, freight, tax percentage and insurance etc. in clear terms.
02. Quantity of discount, if any, should be indicated clearly.
03. This institute is registered with the Department of Scientific & Industrial Research (DSIR), Govt. of India for purposes of availing custom duty exemption in terms of Government. Notification No 51/96-Customs dated 23 July 1996 and central excise duty exemption in terms of Government Notification No. 10/97-Central Excise dated 1 March 1997.

06. The rates quoted should be valid for 90 days from the date of opening of quotation.

07. Quotation should be submitted along with printed literature/ catalogue of the quoted make/ model and authorization certificate of the manufacturer. Quotation without mention of make/Brand shall not be considered.
08. There should be no cutting/ overwriting. The cutting if any should be duly attested.
09. Unattested/amended/overwritten figures will not be considered.
10. In all matters of disputes, the decision of the Director of this Institute shall be final and binding.
11. Minimum period of delivery of the stores/materials should clearly be specified in the quotation.
12. TDS/ VAT will be deducted from the bill as per applicable tax rules of GOI/M.P. Govt.
13. PAYMENT TERMS: Payment will be made within reasonable time say within 30 days from the date of receipt of material in good condition without any damage and in fully installation of the equipment the in accordance with the ordered specification at the end. **Since the mode of payment will be e-payment system, hence Bank Account Number, name of bank with location and IFSC Code Number of Bank may be furnished on the body of the bill.**
