1. Valid GST No. may be furnished.
2. Prices to be quoted on F.O.R. Nabi Bagh, Bhopal basis and valid up to one year from the date of award of contract.
3. It should be clearly stated whether the rates quoted by the firm are inclusive of tax.
4. Incomplete or vague tenders will be rejected. There should be no cutting / overwriting. The cuttings if any should be duly attested. Unattested/ Amended/ overwritten figures will not be considered.
5. Payment Terms: Payment will be released within reasonable time, say within 30 days after successful and satisfactory execution of work orders. Request for advance payments, delivery against payment or payment against dispatch will not be accepted.
6. In case delivery is not done as per stipulated/mentioned prescribed date of this Institute work order or a maximum of one month whichever is earlier, a penalty can be charged @ 0.5% per week, subject to a maximum of 10% of the cost. The work order will be treated as cancelled automatically at the contractor risk and cost including forfeiting the EMD/ Security Deposit. Any delay or inability for completion / execution of work may please be intimated immediately.
7. Firm may obtain approval of proof of document to be printed from Indenter.
8. EMD (BID Security) : **Rs.10,000 (Rs. Ten Thousand Only)** In the form of Demand Draft only drawn in favour of " ICAR UNIT–IISS,BHOPAL" on any nationalized bank at Bhopal.
9. **Security deposit:** The successful bidder will be required to deposit security deposit **Rs.50,000/- (Rupees Fifty Thousand Only)** within 10 (Ten) days after the issue of letter of award by this Institute.
